3/9 - 11th Feria Anual Salud y Bienestar de Telemundo

El Domingo (Marzo 9, 2014) ocurrió la 11th Feria Anual Salud y Bienestar de Telemundo. Este evento familiar se enfocó en la salud y el bienestar. 11th Annual Telemundo Health and Wellness Fair - On Sunday, March 9, 2014 the 11th Annual Telemundo Health and Wellness fair took place at the Convention Center in downtown LA. The focus this year was overall health and well-being. Admission was free and those attending had access to free health exams focusing on glaucoma, high blood pressure, cholesterol, diabetes, BMI, eye exams, immunization, demonstrations on healthy cooking, and exercise classes. A 30 minute presentation in Spanish on the CCI was given for participants attending the fair. Materials in Spanish about the CCI were also distributed throughout the day to more than 3,000 beneficiaries and their families. Spotlight On: Rina Cruz

Rina is an outreach coordinator in Los Angeles County and is fluent in Spanish. Rina's interest in health care stems from the work she did as a volunteer in Guyana, where she worked for three years as an Educational Community Promoter and as a Volunteer Leader with the Peace Corps.

In Guyana, Rina worked with community leaders, community members, and Government Ministries to plan, implement, and evaluate the delivery of health education in five regions of the country. The target groups for this initiative were youth living in remote communities; they received health talks with a focus on HIV/AIDS and workshops on life skills and behavior change. Rina graduated from the University of California, Los Angeles with a degree in Latin American Studies.

What's your favorite part of the CCI to explain to beneficiaries?

The best part of the CCI to explain to beneficiaries is the benefits of care coordination. I believe in the program and I think that it will make a difference not only in the life of the beneficiary but in the life of their families as well.

If you could have created any one work of great art-a song, a painting, a movie, etc.- what would it be?

This is hard because I am a music lover, but I have to say that if I could have created any one piece of art it would have to be "The Kiss" by Klimt. I love the vibrancy of the colors, the depiction of the inner struggle of surrendering.



3/6: Inland Empire Ethnic Media Roundtable

The series of ethnic media roundtables highlight the beneficiaries and frontline providers who will be participating in and benefiting from Cal MediConnect and the Coordinated Care Initiative continued in the Inland Empire this week, with a focus on Riverside and San Bernardino Counties.

- Several dual eligible beneficiaries and family caregivers shared stories of the fragmented care they have been receiving, with one caregiver saying she can't wait for enrollment and the improvement coordinated care will provide to their family life.
- Gilbert Saucedo, HICAP Counselor in San Bernardino & Riverside Counties, gave an overview on the CCI and CalMediConnect. Lately, 90 percent of calls to HICAP have been CCI-related, which suggests that beneficiaries are opening their notifications, and seeking help.
- Carolyn Joyce of the Aging and Disability Resource Connection and Community Access Center in Riverside talked about how previous health care changes were not well planned, so beneficiaries were uncertain of changes to come, which is why advocates like the attendees have
