This letter is to inform you that the Centers for Medicare & Medicaid Services (CMS) is approving your requested technical corrections to California's section 1115(a) demonstration (11-W-00193/9), entitled "California Bridge to Reform Demonstration." Specifically, we are revising the special terms and conditions (STCs) approved on March 19, 2014, to address the following issues:

- Clarifying the transition process for beneficiaries previously enrolled in the Health Care Coverage Initiative (HCCI);
- Correcting technical errors in Attachment F Supplement 4 (Determination of Allowable Costs to Uninsured Individuals for Mental Health Services);
- Attaching previously approved demonstration protocols (Attachment G – Low Income Health Program and corresponding supplements) to the demonstration's STCs;
- Correcting technical errors Attachment J (Low Income Health Program Administrative Cost Claiming Protocol);
- Attaching previously approved measure specifications to Attachment Q Supplement 1; and,
- Revising the dates for enrollment in the Coordinated Care Initiative (Attachment U).

In addition, CMS is approving Attachment F – Supplement 6 "Determination of Allowable Costs for Contracted Services to the Uninsured." This protocol has been attached to the STCs as well.


