Los Angeles County

- 7/23** - Over 200 residents from **TELACU Vistas** participated in a day-long health fair for information on health updates. Seniors had access to health screenings for stroke, bone density, diabetes, and blood pressure. Residents who received Cal MediConnect notices had many questions answered. For further assistance, participants received fliers in Spanish, Chinese, and Korean with important contact numbers for Health Care Options and HICAP.


San Diego County

- 7/25** - At **SanDI-CAN's Community Wellness & Resource Expo**, consumers were able to collect resources on preventive health and participate in health screening diagnostic tests, such as blood sugar tests. A booth on the CCI was available for consumers and other vendors to learn more about Cal MediConnect and the MLTSS program.

7/16 - Patients at **Hzor Adult Day Health Center** in Pasadena participated in a CCI presentation delivered in English, with the option to listen in Armenian via available headsets. This event was made possible by a sponsorship from the five participating Cal MediConnect plans in Los Angeles and Pals for Health, a local organization that provided the interpretive services. The event was promoted in local Armenian newspapers and throughout the community.

Alameda County

- **7/25** - The public **Alameda Stakeholder Meeting** facilitates communication between the two CCI health plans, community stakeholders, and other interested parties.

Los Angeles County

- **7/21** - The five Cal MediConnect health plans sponsored an event marketed for the **Arabic-speaking community** at **Hzor ADHC**. Representatives from the health plans were available for questions, as was an Arabic interpreter.
- **7/22** - At the **Annual Office Manager Presentation and Luncheon for Family Care Specialists IPA**, office managers and billing staff learned details about the upcoming health care changes and how these would affect their patients.
- **7/22** - In Long Beach, 24 residents of **Providence Gardens** learned more about Cal MediConnect. Several were excited to find out that their current plans are participating in Cal MediConnect and Medi-Cal Managed Long Term Services and Supports.

- **7/23** - At the **Grancell Village campus** of the **Los Angeles Jewish Home**, staff gathered for a training on the CCI. With about 35 attendees present, the session covered the details of enrollment and provided additional resources to assist the staff.
- **7/24** - Members of the **Long Beach Health Collaborative** received a presentation on the CCI. The group has previously focused specifically on Medi-Cal outreach and education within the Long Beach community.
- **7/24** - Staff from the **Pomona Health Centers** and **Premier Family Medicine** joined a webinar that provided information on the CCI in both Los Angeles and San Bernardino counties. Two additional webinars are scheduled for this group and their on-site staff.
- **7/25** - Residents of **Sherman Oaks Senior Housing** received presentations about the CCI in both English and Russian.
- **7/25** - The billing, administration, and front office staff at **High Desert Medical Group** received a training on the CCI. Participants learned about enrollment options and timelines as well as resources available to those eligible for Cal MediConnect.

Riverside / San Bernardino Counties

- **7/24** - The billing and administrative staff of **Reche Canyon Regional Rehabilitation Center** received a presentation on the CCI. They learned about the enrollment timeline, notices, and resources available to those eligible for the program, such as Health Care Options and HICAP. The staff also learned about how continuity of care will function under Cal MediConnect.

San Diego County

- **7/22** - Staff at **La Jolla Nursing and Rehabilitation** received an overview of the CCI program. They learned the importance of care coordination under Cal MediConnect and how the notices will reach their patients. They were encouraged to check their patients' eligibility and enrollment in the program.
- **7/23** - Enrollment specialists and social workers at **St. Paul's PACE** received a training on the CCI. Staff members provided a luncheon to discuss the CCI program. PACE is the third option that eligible consumers can pick from on the Choice Forms if they meet the criteria of the program. There are two PACE programs in San Diego, which cover the central, east and southern parts of the county. The centers have in-house doctors, nurses, dentists, prescription medication and social workers. Their services include outpatient labs, X-rays, emergency, urgent care and long-term care services.
- **7/23** - The **CCI Communication Workgroup** shared updates on consumer experiences from IHSS, AIS Call Center, MSSP, 211, HCO, HICAP, CHEA Ombudsman Program, CBAS, PACE, HASDIC, and other stakeholders.

San Mateo County

- **7/24** -The **San Mateo County Long-Term Care Ombudsman** received updates on the CCI in other counties and learned more about the Cal MediConnect Ombudsman services.

Santa Clara County

- **7/22** - The bi-weekly **Santa Clara Communication Committee Meeting of stakeholders** involved in CCI outreach education met to discuss projects and target groups.
- **7/22** - Seniors came dressed in their best and enjoyed a photo day at the **Eastside Neighborhood Center Senior Photo Day**, complete with a professional makeup artist and photographer. After having their picture taken and before sitting down to lunch, seniors collected bags with fliers about the CCI and had the opportunity to ask questions to reps from both health plans.
