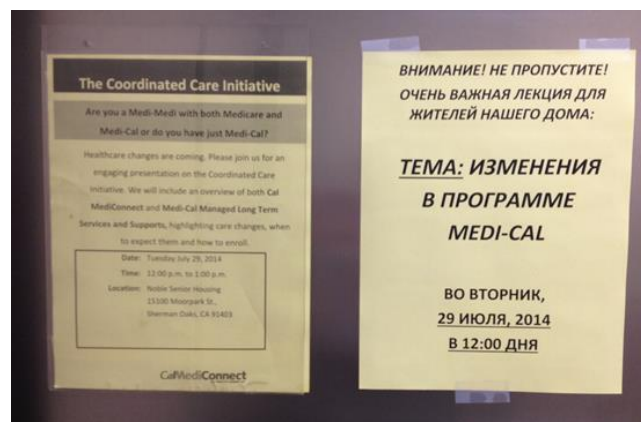
### Los Angeles County
