



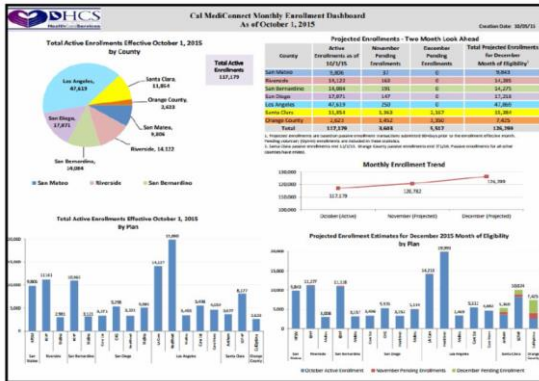

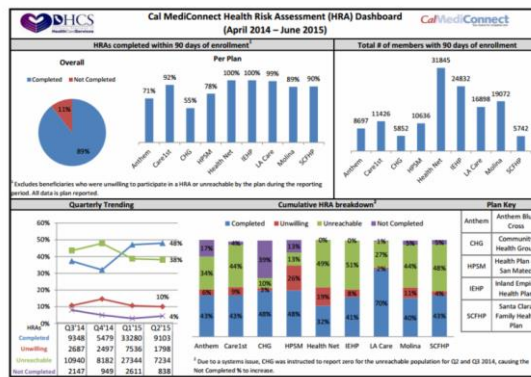

Santa Clara County

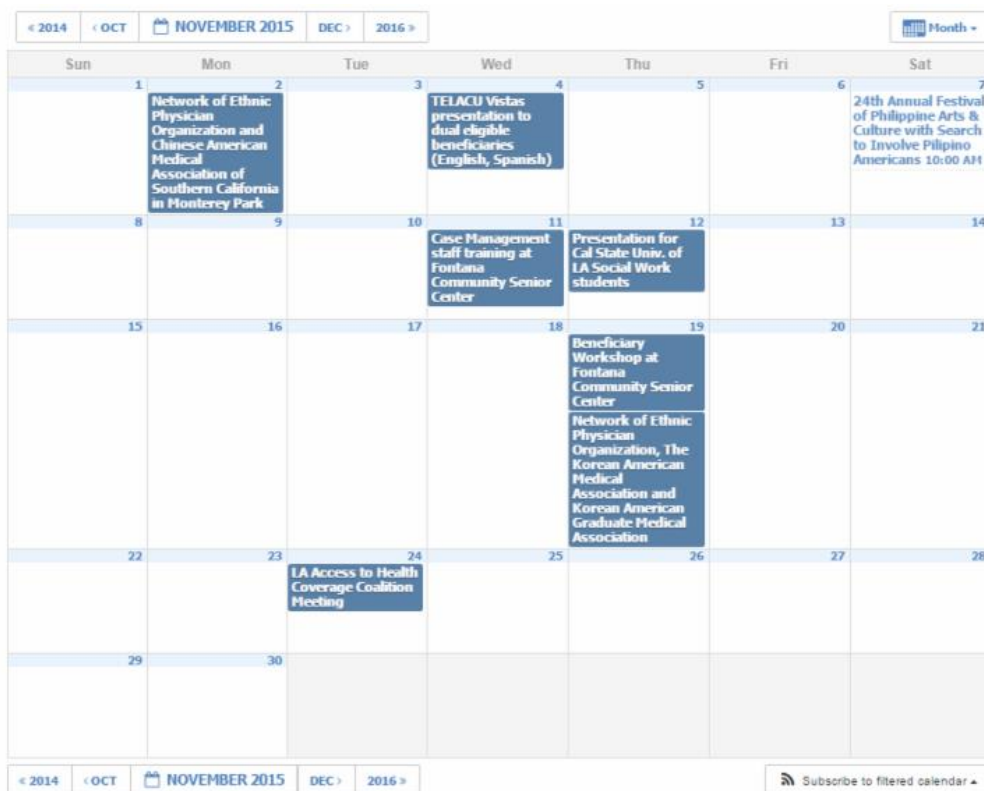
