Update on the CCI Comprehensive Strategy

On Friday, July 1st, the Department of Health Care Services (DHCS) released for stakeholder comment a DRAFT Cal MediConnect Voluntary Enrollment Strategy for 2016. This strategy is designed to expand awareness of Cal MediConnect and encourage voluntary enrollment. This strategy incorporates many of the lessons learned about how best to reach and educate beneficiaries and providers about the Coordinated Care Initiative and Cal MediConnect. It builds on the work already underway by DHCS and its partners, and includes streamlined enrollment and mandatory Medi-Cal plan enrollment for managed long-term services and supports. Third Wave of Polling Results Finds Increased Satisfaction

Field Research Corporation released the third wave of data of the Rapid Cycle Polling Project, an ongoing tracking survey of beneficiaries' experiences in Cal MediConnect health plans. The results show increasing proportions of Cal MediConnect enrollees are satisfied with the health care services they are receiving and more confident in managing their health conditions. A presentation was given in both English and Korean about the benefits, protections, and enrollment process for the program. Following the presentation, representatives from CalOptima, HICAP, and the Orange County Ombudsman met with beneficiaries who had questions and partner agencies gave beneficiaries various resources.
